

The 07 watch duty system as per rule should be implemented immediately but not later than 19.03.2018(Monday).

Individual units under the Directorate of Correctional Services shall furnish with a compliance report by 19th of the instant invariably.

With reference to your Memo No. 1745/RTI-13/2018 dated 26.04.2018, on the
above Subject, I am directed to state in respect of the information as sought for are as
follows:-

A). Against Nilanjan Pandey's application (information in order of chronology):-


1. Cash allowance in lieu of subsidized ration was introduced with effect from 01.04.1981.
2. All Jail employees up-to the rank of Controller (Deputy Jailor) and below including Guarding Staff in regular establishment receive the Cash Allowance in lieu of Subsidized Ration.
3. Cash Allowance is given in lieu of Subsidized Ration.
4. Cash Allowance in lieu of Subsidized Ration has been increased thrice in the following manner :-
 - a) From Rs. 75/- to Rs. 100/- per month per head ,
 - b) From Rs.100/- to Rs.200/- per month per head ,
 - c) From Rs.200/- to Rs.900/- per month per head.
5. No such event has occurred.

(B).Against Debanshu Sengupta's application (information in order of chronology):-

1. Cash Allowances in lieu of Subsidized Ration @ Rs.900/- and Rs. 200/- per month per head are given to the uniformed officials (Guarding Staff and Executive Officers up-to the rank of Controller) and the non-uniformed officials respectively in regular establishment of Correctional Homes.
2. For the first part of the information, the answer is same as given in (A) 1 above and for the second part, the answer is same as given in (A) 4 above.
3. Yes. The duties and functions of uniformed and non-uniformed employees of Correctional Homes may be perused at Chapter V of the West Bengal Jail Code Volume I (Part-I) and Chapter IV of the West Bengal Correctional Services Act,1992 may be perused.
4. The OSD & Ex-Officio DG&IG of CS, WB may be consulted in the matter.

You are requested to dispose of the matter at the earliest, with intimation to this department
